- To obtain a debit card, clients with accounts in USD, CHF and GBP must have a current account in EUR to be able to apply for and be issued the card. To withdraw money from accounts in foreign currencies, funds should initially be transferred to the EUR account. This card enables the withdrawal of amounts in Euro from the EUR account.
- The bank does not provide term deposits in USD, CHF, GBP. The interest rate for existing time deposits with automatic renewal (6 months) is 0.01%.

The commission fees are calculated based on the currency of the account that initiates or receives the transaction at issue. Outgoing international transfers from a EUR account may be initiated in other currencies like USD/CHF/GBP. Outgoing payments from accounts in foreign currencies like USD/CHF/GBP can be carried out when the receiving account is in the same currency as the ordering account or in EUR.
- Incoming international transfers in EUR and USD in the amount of over ≥ 1 million Euro received by the correspondent bank after 16:00 hrs will be credited to the recipient's account on the following working day.
